Personal data that we process

M&C Protect B.V. processes your personal data because you use our services and / or because you provide them to us yourself. Below you will find an overview of the personal data that we process:

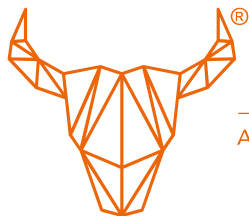
- First and last name
- Address details
- Telephone number
- E-mail address(es)
- Bank account number
- VAT number
- Other personal data that you actively provide, for example by creating a profile on this website, in correspondence and by telephone
- IP address
- Internet browser and device type
- Data about your activities on our website

Special and/or sensitive personal data that we process

Our website and/or service does not intend to collect data about website visitors who are younger than 16 years of age. Unless they have permission from parents or guardian. However, we cannot check whether a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children, in order to prevent data about children from being collected without parental consent. If you are convinced that we have collected personal information about a minor without this permission, please contact us via bas@m-c.eu and we will delete this information.

For what purpose we process personal data M&C Protect B.V. processes your personal data for the following purposes:

- To offer you the possibility to create an account
- To deliver goods and services to you
- To handle your payment
- To be able to call or e-mail you if this is necessary to be able to perform our services
- To inform you about changes to our services and products
- Sending our newsletter and / or advertising brochure
- M&C Protect B.V. also processes personal data if we are legally obliged to do so, such as data that we need for our tax return.

**How long we store personal data**

M&C Protect B.V. does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. For invoicing and our financial administration, we process your name, any company name, billing address, e-mail address, Chamber of Commerce number, VAT number, customer number, bank details and other necessary data. Based on the legal obligation of the tax authorities, we will keep this data for 7 years.

Sharing personal data with third parties

M&C Protect B.V. does not sell your data to third parties and only provides it if this is necessary for the execution of our agreement with you or to comply with a legal obligation. With companies that process your data on our behalf, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. M&C Protect B.V. remains responsible for these processing operations. Cookies are also placed on this website by third parties. These are, for example, companies that provide embedded content and/or perform website analysis. Cookies, or similar techniques, that we use M&C Protect B.V. uses functional and analytical cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. M&C Protect B.V. uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website work properly and to be able to optimize it. In addition, cookies are placed by third parties. These are cookies for analytical and statistical systems to provide insight into how visitors use the website, so that we can improve the website and our services. On your first visit to our website, we have already informed you about these cookies and asked for permission to place them. You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously stored via the settings of your browser.

View, modify or delete data

You have the right to view, correct or delete your personal data. You can do this yourself via the personal settings of your account. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by our company and you have the right to data portability. This means that you can submit a request to us to send the personal data that we hold about you in a computer file to you or another organization mentioned by you. If you wish to exercise your right to object and/or to data portability or if you have other questions/comments about the data processing, please send a specified request to bas@m-c.eu. To ensure that the request for access has been made by you, we ask you to send a copy of your proof of identity with the request. In this copy, make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) black. This is to protect your privacy. M&C Protect B.V. will respond to your request as soon as possible, but in any case within four weeks. M&C Protect B.V. would also like to point out that your rights are included in the General Data Protection Regulation (GDPR).
